



BRIEF PRESENTATION OF THE CRUP

What is the CRUP?

The Council of Rectors of Private Universities (acronym in Spanish: CRUP -*Consejo de Rectores de Universidades Privadas*-) is a representative and consultative organization for the Private University members and before the State. It takes as functions to represent in joint form to all the authorized establishments, to program the planning of the private university education and to coordinate the work with the competent organs of the Department of Education and of the Rectors' Councils of the State and Provincial Universities.

What are its functions?

The CRUP expresses opinion before the Department of Education in the cases foreseen by the legal norms, in the problems that affect the private university or its set and ready collaboration and the mutual help encourages between the entities members. All of this, for the attainment of the ends and proper targets of a university and of the initiative deprived in the university higher education, in addition to:

- To represent jointly to all the authorized establishments.
- To program the planning of the private university education and coordinates this work with the competent organs of the Department of Education and of the Rectors' Councils of the State and Provincial Universities.
- To express opinion before the Department of Education in the cases foreseen by the legal norms, in the problems that affect the private university or its set.

- To give collaboration and the mutual help encourages between the entities members, for the attainment of the ends and proper targets of a university and of the initiative deprived in the university higher education.

What are its direction organs?

There are organs of direction of the Principals' Council of the Private Universities:

- The Plenary Advice;
- The Managing Commission;
- Commissions in which the CRUP takes part in the Department of Education:
 - o National Commission for the Improvement of the Higher Education.
 - o Council of Universities (acronym in spanish: CU).
 - o National Commission of Evaluation and University Accreditation (acronym in spanish: CONEAU).
 - o Council of Regional Planning of Higher Education (acronym in spanish: CPRES)

How it constituted and what functions has the Advice Plenary?

Constitution:

The representation of the entities constitute its members and it will be possible to meet in the place that he gets ready.

It has summoned by the President of the Advice, monthly in an ordinary way; and with extraordinary character, when it has needed on the fifth part like minimum of the universities that they integrate the Advice.

All the entities have a right to voice and vote, being able to make representations to the effects of the vote.



Functions of the Plenary Advice:

To decide on the aspects that they have fixed in this State, like top organ of the Rectors Advice.

To constitute commissions - whose President is a Rector – to make works documents and to give an opinion on the matters that the Advice will treat.

In the questions of form and internal functioning of the Advice, the resolution of the present majority, it will be obligatory for all the universities. It will not be as soon as the determination affects the philosophy or doctrine of any of the universities.

Which universities are members of the CRUP?

The private Universities and private University Institutes that integrate the CRUP are those authorized by the Argentine National State.
